



DATA PROTECTION POLICY

AmTrust (defined below) will in connection with your expressed interest in or your subscription of insurance process your personal data.

The defined term "AmTrust", "we" or "us" in this policy refers to the following companies within the AmTrust Group: AmTrust Nordic AB (556737-0431) and AmTrust International Underwriters DAC (169384). Each AmTrust company that processes your personal data is a controller and responsible for its processing.

This policy summarise the main ways in which AmTrust process your personal data and your rights towards us and how to exercise them, for more information please visit our website at www.amtrustnordic.se or contact AmTrust's data protection officer at the address stated below.

1. Information that we may collect or receive about you

We may collect and process personal information that you provide directly to us or which we receive through third parties (for example, public records, insurance intermediaries, claims handlers and other business partners). This may include the following categories of data:

- General identification and contact information and information enabling us to provide products and services;
- Financial information and account details;
- Information which is necessary to discover, prevent or investigate fraud or investigations towards financial sanctions lists;
- Telephone recordings; and
- Marketing preferences.

We may, after you have given your consent, process sensitive information about you such as data concerning health or union membership.

2. How we use your information

Processing of personal data are normally preformed and necessary in order for us to fulfil our contractual obligations towards you under the insurance contract or applicable legal requirements. We may also process personal data with reference to our legitimate interests of product development or marketing our products. Personal data will only be retained as long as required for each purpose stated in this policy and thereafter erased.

3. Transfer of personal data

AmTrust may, when necessary for purposes stated in this policy, transfer your data to companies within the AmTrust Group, external parties or our businesses partners who are involved in offering products and services to you, our service providers or governmental or other public authorities. Your personal data may be transferred to destinations outside the European Economic Area ("EEA"). We only transfer data to countries deemed as having adequate protection by the European Commission or, where there is no adequacy decision, we use the European Commission approved 'Standard Contractual Clauses' with such parties to protect the data.



4. Your rights

You may at any time ask us not to process your data for marketing purposes or change your preferences for marketing. If you identify that any personal data related to you is inadequate, incomplete or incorrect, you are entitled to have the personal data corrected. You also have the right to request access to the personal data that we store about you or revoke a consent given, right to objection, right to erasure, right to revoke of given consent, right to restriction, right to data portability, rights in relation to automated decision-making, including profiling and lodge complaints pertaining to the processing of your personal data to the local Data Protection Authority.
